The **Jewish Community in Moldova** reported one incident of graffiti on a monument to victims of the Holocaust and one incident in which graves were desecrated with paint in a Jewish cemetery.

World Without Nazism reported one incident of the desecration of a monument commemorating the Holocaust and one incident of graffiti on a school.

The **Information Center "GenderDoc-M"** reported eight physical assaults, four of which also involved robberies and two of which resulted in serious injuries, with one carried out by a group and resulting in the hospitalization of the victim and the second resulting in the victim suffering a broken jaw. **GenderDoc-M** also reported three threats, including two against gay men and one against a lesbian.

In its fourth report, the **European Commission against Racism and Intolerance (ECRI)** expressed concern about inadequate response to hate crimes, and recommended that the police and the judiciary ensure that criminal law is effectively applied in cases of violence against persons belonging to ethnic or religious minorities.
