

Denmark Hate Crime Report 2013

Summary

Denmark regularly reports hate crime data to ODIHR. Hate crime statistics are regularly [published](#) on the Danish National Police website.

The Ministry of Justice conducts annual victimization surveys to measure unreported hate crimes. The Danish National Police [regularly engages in dialogue](#) on hate crime with a number of community stakeholders.

ODIHR's Key Observation

ODIHR observes that Denmark has not reported on the numbers of prosecuted cases or information on sentenced hate crime cases to ODIHR.

Official Data

A year-to-year drop in the number of reported hate crimes is caused by improved separation of hate crimes from other criminal forms of intolerance. Police records also included: 56 crimes in which the “extremist” motive could not be confirmed, 70 cases with political motivation, and additional 9 crimes of discrimination and propaganda,. These cases are not included in the overall figure presented here. The crimes of discrimination and criminal propaganda may, however, be included in the breakdown below.

Police data by bias motivation

59

Racist and xenophobic hate crime

Official police figures record 59 racist and xenophobic crimes, out of which 17 were physical assaults, six cases of vandalism, and 36 cases of threatening behaviour and harassment.

Anti-LGBTI hate crime

Official police figures record 24 hate crimes motivated by bias against LGBT, out of which 11 were physical assaults, 2 cases of vandalism, and 11 cases of threatening behaviour and harassment.

Anti-Muslim hate crime

Official police figures record 17 hate crimes motivated by bias against Muslims.

Anti-Semitic hate crime

Official police figures record 10 anti-Semitic hate crimes.

Official police figures record three hate crimes motivated by anti-Christian bias.

Threats/ threatening behaviour

This category includes cases of “harassment”. Harassment covers incidents involving personal and written contact with the victim, including shouting in a public place, throwing objects at the victim, spitting, general threatening letters and simple physical contact.

National Developments

Hate crimes are an area of focus in the prosecution service's 2012-2015 strategy. Training for prosecutors, lawyers and judges on the identification and prosecution of hate crimes is conducted annually by the Director of Prosecutions. As of 2014, training on hate crimes is being introduced as a mandatory part of the curriculum for police officers.

In September 2013, the government launched a national anti-discrimination unit that is currently carrying out a comprehensive mapping of hate crimes, their victims and perpetrators. A number of key indicators are being developed to measure the current situation. The mapping results are expected to be published at the end of 2014.
