### Summary

France regularly reports hate crime data to ODIHR. Since 2012, [DILCRAH](#) has served as an inter-ministerial body and platform for co-operation to address hate crime, including through research and financial support to civil society organizations (CSOs). DILCRAH, along with a number of CSOs, is also involved in the training of judges and prosecutors, as well as police officers and gendarmes. The Central Office for Combating Crimes against Humanity and Hate Crimes (OCLCH) is an inter-agency body composed of police officers and gendarmes that is responsible for leading and coordinating the fight against crimes against humanity and hate crimes, assisting and supporting local units in this area, acting as the national contact point for both units and external entities, investigating, providing expertise and preparing threat assessments in its area of responsibility.

Hate crime data are regularly [published](#) by the Ministry of Interior. France conducts regular [surveys](#) on hate crime victimization to measure unreported hate crimes.

Official figures record 118 physical assaults and 606 cases of threats.

### Anti-Semitic hate crime

Official figures record 177 physical assaults, 438 cases of threats and forty cases of damage to synagogues or cemeteries.

### Hate crime against Christians and members of other religions

Official figures record 543 cases of damage to churches or cemeteries.

### Anti-Muslim hate crime

Official figures record 54 physical assaults, 149 cases of threats and 84 cases of damage to mosques or cemeteries.

### Anti-LGBTI hate crime

Official figures record 33 physical assaults, including 21 resulting in serious injury; one rape, 114 cases of threats and one case of incitement to violence.

## National Developments

France amended all hate crime provisions contained in its criminal code to include sexual orientation.

A national action plan against racism and anti-Semitism for the period 2011-2014 was adopted in February 2012. An inter-ministerial delegation against racism and anti-Semitism has been established to monitor the implementation of this plan and to co-ordinate the ministries involved. The improvement of data collection mechanisms from both the Ministry of Justice and the Ministry of Interior is one of the goals of the national action plan.
