

## Hungary Hate Crime Report 2018

### Summary

Hungary regularly reports hate crime data to ODIHR. In 2012, the National Police Headquarters established a special hate crime network, which is responsible for supervising hate crime investigations. In the same year, a civil society working group against hate crimes (GYEM) was established with the aim of strengthening co-ordination with police and developing a list of bias indicators, which were adopted by the network and uploaded onto the police intranet. In 2018, the Ministry of Interior hosted a workshop on hate crime recording and data collection. The workshop was co-facilitated by ODIHR and the EU Agency for Fundamental Rights and resulted in a set of recommendations for relevant state authorities.

### ODIHR's Key Observation

ODIHR observes that Hungary's law enforcement agencies have not recorded the bias motivations of hate crimes.

The reported statistics were only broken down by type of crime and, in some cases, by target. Breakdown by bias motivation is not available.

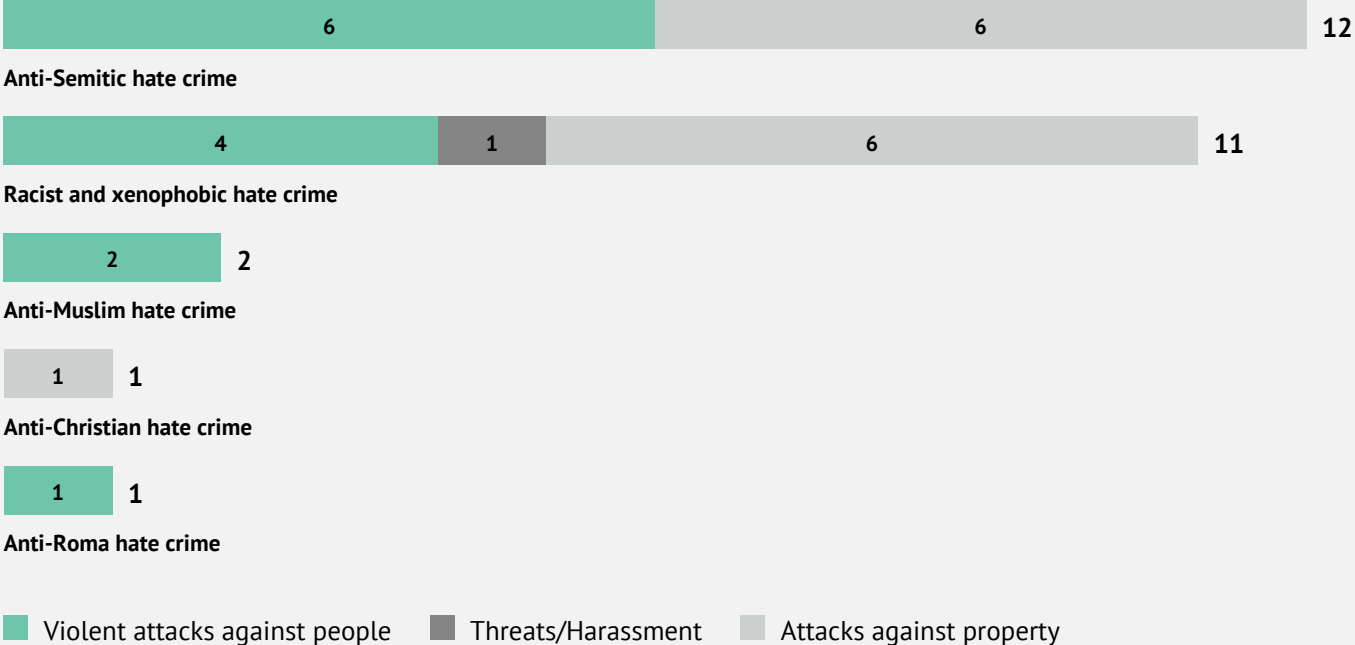
## National Developments

An internal police regulation on hate crime investigation has been developed, with a view to introducing it to police practice in 2019, and will include a methodological guidance, including a list of bias indicators elaborated earlier by a working group of state and civil society organizations. The regulation's implementation will be made mandatory by an order of the police chief.

The **Ministry of Interior**, together with ODIHR and FRA, organized a workshop for police and other criminal justice agencies involved in recording hate crimes. The workshop produced a set of recommendations on improving hate crime registration, which were provided to the Ministry to be conveyed to police for implementation.

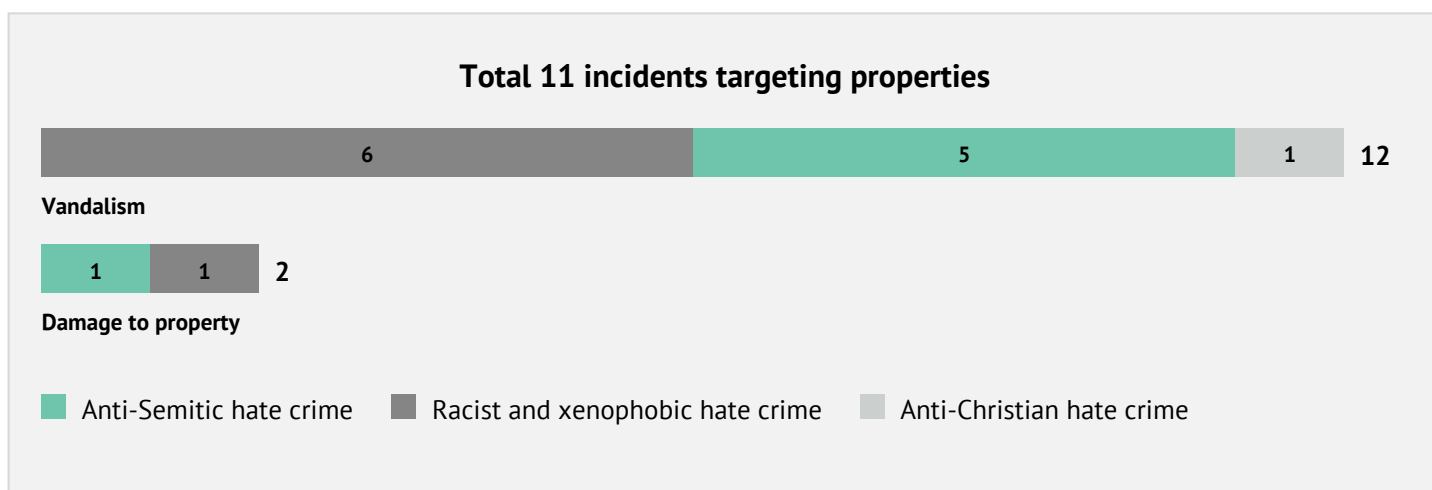
