Summary

Sweden regularly reports hate crime data to ODIHR. Hate crime reports are **published** every second year. Since 2016, the Government has implemented a national plan against racism, similar forms of hostility and hate crime. The plan takes an integrated approach and comprises strategies and measures to prevent and combat racism and hate crime through co-ordination and monitoring, education and research, and support for and co-operation with civil society.

Three different victimization surveys are conducted at one, two and three-year intervals in order to measure unreported hate crime.

Official data included an estimated 179 anti-Semitic hate crimes. The overall figure presented here (168) excludes cases of defamation and hate speech which do not fall within the OSCE definition of hate crime.

Threats/ threatening behaviour

Includes crimes that are officially categorized as 'unlawful threats and non-sexual molestation.'

Physical assault

Includes crimes that for the purpose of the hate crime statistics are categorized as "violent crimes": homicide, assault, violence against a public servant and, although not included in the initial selection process, a further few cases of mugging, gross violation of integrity, gross violation of a woman's integrity and rape.

Vandalism

Includes crimes that are officially categorized as 'criminal damage/graffiti.'

Unspecified crime type

This category includes a selection of other hate crimes besides those mentioned above. For example: Malpractice, crimes against the Personal Data Act, unlawful deprivation of liberty and interference in a judicial matter .

National Developments

The **Police Authority of Skane County** continued to develop and implement the training of specialized police officers in each district on registering and recording hate crimes. The **Crime Victim Compensation and Support Authority** funded several projects on hate crimes, aimed to increase knowledge of victims. The Authority funded a research project in 2011 to explore the causes and consequences of hate crime, and to examine possible means of prevention, with a focus on identifying strategies to improve the situation for victims. Other awareness-raising and capacity-building initiatives targeting specific groups are included in this report under the relevant sections.
